#### **Upward Bound**

• UB1 (serving Fort Ann, Fort Edward, Glens Falls, Hudson Falls, South Glens Falls) received notice of non-continuance (Sept. 12, 2025). In place since 2009 (end date

- 8/31/2027) Program will end Sept. 30, 2025; \$312,480 annually. Appeal filed with U.S. Department of Education; three staff positions at risk with a 90-day transition plan.
- UB2 (serving Argyle, Corinth, Granville, Hartford, North Warren, Salem, Warrensburg, Whitehall) received continuation notice (Sept. 17, 2025; \$309,505 annually).

## **Enrollment Update** (as of Sept. 17, 2025)

As of Sept. 17, overall enrollment remained essentially flat, with a decline in full-time students offset by an increase in part-time enrollment. Residence hall occupancy is still below target, even though the number of applications in progress is sufficient to fill all available beds. Students who have not completed the housing registration process most often cited cost concerns as the primary reason for not committing.

- Full-time enrollment: 1,252 (-3.7%).
- Part-time enrollment: 723 (+12.1%).
- College Academy enrollment: 652 (+5.7%).
- FTE: 883.4 (+0.1%).
- 605 students ages 25–55; 464 Reconnect-eligible; 236 with unmet financial need.
- Regional enrollment shifts: Warren +11.3%, Washington +6.4%, Saratoga –4.4%.

#### Saratoga Branch Campus Planning (2025–2026)

- Focus areas: Business, IT/Engineering, Healthcare.
- Planned initiatives: CNA training, cybersecurity microcredential, guest speaker series, workforce bootcamps.
- Funding secured through SUNY Future of Work Centers (\$1.25M), SUNY High Demand Programs (\$35k), SUNY Operating Aid Increase (\$130k), NYS Clean Energy Microcredential Initiative (\$375k, renewable), and a DOH HELP grant (\$5M over 5 years).
